

NOTICE OF PUBLIC HEARING

CITY OF BELFAST PLANNING BOARD

The City of Belfast Planning Board, at its meeting of April 14, 2021, beginning at 6:00 pm or as soon as practical thereafter, shall conduct a public hearing on the Final Site Plan application from Developers Collaborative, applicant, to construct 48 multi-family housing units on the former City Public Works garage property located at 115 Congress Street, Map 35, Lot 43. Project requires a Site Plan Permit from the Planning Board, reference City Code of Ordinances, Chapter 90, Site Plan. A sketch plan of the project was considered by the Planning Board on September 16, 2020 and a Preliminary Plan was reviewed on February 24, 2021.

The property is 4.5 acres and is located in the Residential 2 Zoning District. Multi-family housing is a permitted use in this zoning district subject to review by the Planning Board pursuant to Chapter 90, Site Plan and Chapter 102 Zoning of the City Code of Ordinances.

The Planning Board will be conducting the Board meeting and this public hearing electronically via ZOOM. The Planning Board will not physically be meeting in City Hall and the public will have no access to City Hall during the Board meeting. All Board members will electronically be participating in the meeting via ZOOM from their respective homes. The public can view the meeting in any of the following ways: it will be streamed live on the city website (cityofbelfast.org), and it can be seen on BEL-TV.

Persons who may be affected by this project who want to offer comment at the public hearing can do so in any of the following three ways:

- 3) When the Board meeting is in session on April 14, you can send an email to public@cityofbelfast.org. The City moderator of the ZOOM meeting will read any emails that are sent to the Board.
- 4) During the meeting, you can make oral comment using the ZOOM platform. You should consult the City website, cityofbelfast.org, reference Planning and Codes link, for specific information on how to access the website to offer comment via ZOOM.
